Terms and Conditions

1. Deposits and Payments. The Client shall make a deposit to retain 'Indigo Perspective' to perform the services specified herein. At such time as this order is completed, the deposit shall be applied to reduce the total cost and Client shall pay the balance due. The deposit is non-refundable. If the Client refuses delivery of the order or refuses to pay within thirty 30 days of this order, Client shall be in default hereunder and shall pay 6.5 percent interest on the unpaid balance until payment is made in full.

2. Prices. All quotes remain valid for 28 days, all other charges in this Agreement are based on 'Indigo Perspective' current Price Lists. This price list may be adjusted without notice and future orders shall be charged at the prices in effect at the time when the order is placed. We do not offer any refunds on special orders.

3. Copyright and Reproductions. 'Indigo Perspective' Photography retain full, unlimited, world-wide copyright on all photographs supplied. These photographs are solely for personal display purposes. They may not be copied, published, reproduced, or stored on any electronic retrieval system without the express written permission of 'Indigo Perspective'. 'Indigo Perspective' shall only make reproductions for the Client or for 'Indigo Perspective's' portfolio, samples, self-promotions, entry in photographic contests or art exhibitions, editorial use, or for display within or on the outside of the Photographer's studio. If 'Indigo Perspective' desires to make other uses, 'Indigo Perspective' shall not do so without first obtaining the written permission of the Client. 'Indigo Perspective' may wish to release copyright or reproduction rights for the images for an agreed amount, which may not be passed to any third party whatsoever.

4. Photographer. 'Indigo Perspective' may substitute another photographer to take the photographs in the event of Photographer's illness or scheduling conflicts. In the event of such substitution, Photographer warrants that 'Indigo Perspective' taking the photographs shall be a competent professional.

5. Failure to Perform. If 'Indigo Perspective' cannot perform this Agreement due to a fire or other casualty, strike, act of nature, or other cause beyond the control of the parties, or due to 'Indigo Perspective' illness, then 'Indigo Perspective' shall return the deposit to the Client but shall have no further liability with respect to the Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of 'Indigo Perspective'. In the event 'Indigo Perspective' fails to perform for any other reason, 'Indigo Perspective' shall not be liable for any amount in excess of the retail value of the Client's order.

6. Cancellation. If Client shall cancel within 28 days of the session date the full amount due will be required for payment within 30 days.

7. Client's Usage. The Client is obtaining prints for personal use only, and shall not sell said prints or authorize any reproductions thereof by parties other than 'Indigo Perspective'. If Client is obtaining copyright or reproduction rights 'Indigo Perspective' authorises the Client to reproduce the print only as agreed in writing. In such event, Client shall request that a credit for 'Indigo Perspective' be placed adjacent to the photograph on any publication, but shall have no liability if the publication refuses or omits to do so.

8. Match to original. (Likeness to person/colour). In accordance with the accepted practises of all professional photographers and photographic laboratories, the return of any technically acceptable photographs or prints or demands for refund or refusal to settle charges cannot be entertained on principle. No exception whatsoever can be made to this rule as we cannot be held responsible for individual tastes or expectations.

9. Inherent Qualities. Client is aware that colour dyes in digital photography may fade or discolour over time due to the inherent qualities of dyes, and Client releases Photographer from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.

10. Client's Originals. If the Client is providing original prints, negatives, or transparencies owned by the Client to 'Indigo Perspective' for duplication, framing, reference, or any other purpose, in the event of loss or damage 'Indigo Perspective' shall not be liable for the cost of the materials used.

11. Miscellany. This Agreement incorporates the entire understanding of the parties. Any modifications of this Agreement must be in writing and signed by both parties. Any waiver of a breach or default hereunder shall not be deemed a waiver of a subsequent breach or default of either the same provision or any other provision of this Agreement. English Law shall govern this Agreement.
